Midwest Society of Periodontology Annual Meeting – February 27-February 28, 2010

The Midwest Society of Periodontology is an organization of 425 periodontists in the Midwestern States. We have an annual meeting each winter which piggy-backs with the Chicago Dental Society's Midwinter Meeting. This year our Annual Meeting is to be held on Saturday and Sunday February 27-February 28, 2010 at the Renaissance Chicago Hotel. We expect an attendance of between 300 and 325 members and professional guests. Last year our attendance exceeded 300 periodontists, graduate students and restorative dentists.

Saturday's program will feature a Graduate Student Research Forum. Postdoctoral students and recent graduates in periodontology submit abstracts to compete in the Midwest Society of Periodontology's Graduate Student Research Forum. Three students are selected to present in Chicago and each of these three finalists will receive a \$500 cash award plus their hotel expenses. In addition, a first place plaque will be presented to the winner and honorable mention plaques will be given to the other two presenters.

Saturday's program will include the following speakers and topics: Dr. Guilio Rasperini - "New Frontiers in Periodontal and Peri-implant Regeneration" and Dr. Kenneth Kornman - "New frontiers in periodontics: Where have we come from? Where are we now? Where are we going?" The Sunday morning session will feature an outstanding program by Dr. Craig Misch - "Managing Complex Implant Cases"

Dr. Sam Low, President of the American Academy of Periodontology, will open the meeting on Saturday morning with a short address. Saturday also will include a Luncheon for Learning Session limited to 60 participants. The speakers will discuss various topics in periodontics.
